## **Opening session - Innovation in a time of policy change**



#### **Dr. Paul Seward**

I was raised on a small farm in UK, where I developed a love for farming, nature, and the outdoor life. After leaving school, I travelled extensively, and worked on a number of farms where I further developed my interest in agriculture, and international development. I then studied Agricultural Science (Crop Science) at Leeds University, and did my PhD in Soil Science/Plant nutrition at the University of Reading (UK).

After University, I worked for a Fertilizer Company (now Yara), as a scientist in their Centre for Plant Nutrition and Environmental Research in Germany, to develop new innovative fertilizers. In 1992, I joined the Tropical Soil Biology and Fertility Programme (TSBF), based in Nairobi, where I assisted to co-ordinate soil fertility research by scientists in National Agricultural Research Institutes and Universities in East and Southern Africa. After 3 years at TSBF I returned to work in the fertilizer research Centre in Germany, but continued to advise, on a voluntary basis, a Kenyan NGO on how to improve soil fertility, how to rapidly create demand for, and how to help small-holder farmers gain access to the appropriate fertilizers to improve their food security. This proved to be successful and in 2000, I returned to live in Kenya to scale up this work in partnership with private sector Farm Input Supply Companies.

In 2003, I founded and started to work for Farm Input Promotions Africa Ltd. (FIPS-Africa) which is a not-for-profit Kenyan Company dedicated to improving the food security and livelihoods of small-holder farmers in East Africa. For 15 years, I travelled widely within the Region to work with, and learn from, numerous smallholder farmers and to assist develop a private sector-led Extension Approach to catalyze the adoption of the appropriate farm inputs to improve the productivity of a diverse range of crops and livestock. This Extension Approach, which involves the selection and training of self-employed Village-based Advisors, benefited hundreds of thousands of small-holder farmers in Kenya, and Tanzania, in a sustainable way. I have also advised private sector seed and fertilizer Companies in Nigeria, DR Congo and South Sudan on how to implement the Approach.

For the last 4 years, I have worked for the Alliance for a Green Revolution in Africa (AGRA) as Head of Extension and Capacity building, based in Nairobi. My main role has been to advise partners on implementation of a private sector-led extension approach to directly improve the crop productivity and incomes of 9 million small-holder farmers in 11 Countries in sub-Saharan Africa.



## **Jacki Davis**

Jacki Davis is a leading commentator and analyst on European Union affairs. She is an experienced journalist, speaker and moderator of high-level events; a regular broadcaster on television and radio news; and a Senior Adviser to the Brussels-based think tank, the European Policy Centre. She has been based in Brussels for nearly 30 years, and was previously the EPC's Communications Director; editor-in-chief of E!Sharp, a magazine on EU affairs; launch editor of European Voice, a Brussels-based newspaper on EU affairs owned by The Economist Group, from 1995-2000 (now Politico); and Brussels correspondent of a British national newspaper.

#### **Karin Nienstedt**

Dr. Karin Nienstedt leads the Sector Pesticides – placing on the market in the unit "Pesticides and Biocides" of the Directorate-General for Health and Food Safety of the European Commission. Before joining the European Commission in 2010, she worked in the European Food Safety Authority (EFSA) as scientific officer for the PPR Panel. She also worked several years in academia and in a GLP-contract research facility on topics related to crop protection and ecotoxicology.



#### **Jean Pierre Busnardo**

Jean-Pierre Busnardo is a former European Regulatory Affairs Leader for Corteva agri-science in Brussels. An agronomist by background, he started his career in Africa where he conducted agronomic research on tropical food crops. He joined the crop protection industry in 1986 and worked for various companies before joining DuPont in 1993. He has held portfolio regulatory assignments at national, European and global levels before working in Regulatory Affairs from 2003. Manuela Tiramani was appointed Head of the Pesticide Peer Review Unit (PREV) of the European Food Safety Authority in January 2019. #### **Domenico Deserio**

Domenico Deserio is a Policy Officer in the Directorate General for Health and Food Safety of the European Commission (DG SANTE). He is responsible for policies related to micro-organisms used as active substances in plant protection products. Within the EU Biopesticide Working Group, he is currently working on the amendment of Regulations concerning placing on the market of microbiological active substances and plant protection products. #### **Andrew Owen-Griffiths**
